2. If your application is complete and you qualify to vote by mail ballot, a mail ballot package will be sent to you on October 1, 2018. If we receive your application after October 1, 2018, time may be insufficient for mailing and receipt; we recommend that you arrange to pick up a mail ballot package from Legislative Services.
3. You are responsible for ensuring that your completed ballot and documents are received by the Chief Election Officer on general voting day, Saturday, October 20, 2018, before the close of voting at 8 p.m.

- 18 years of age or older on general voting day October 20, 2018; and
- a Canadian citizen; and
- a resident of British Columbia for at least six months immediately before the day of voter registration; and
- a resident of the municipality for at least 30 days immediately before the day of voter registration; OR a non-resident owner of real property in the municipality for at least 30 days immediately before the day of voter registration; and
- not disqualified by law from voting in an election or otherwise disqualified by law;

and that I am eligible to vote by mail for the following reason(s) (**check at least one**):

- I have a physical disability, illness or injury that affects my ability to vote at another voting opportunity for this general election; and/or
- I expect to be absent from the municipality at the times of **all** advance voting opportunities, October 6, 9, 10, 11, 12, 14 and 15, 2018, and on general voting day October 20, 2018.
